OUR STORY:

Ahimsa House, meaning "nonviolence" in Sanskrit, was founded in 2004 by Emily Christie after she lost a pet to domestic violence. Ahimsa House became Georgia's first and only organization dedicated to helping the human and animal victims of domestic violence reach safety together.

Originally, Ahimsa House maintained a central shelter for animals at a secret location in metro Atlanta. In Fall 2006, we recognized the need to change our program model in an effort to operate more cost-effectively and to better serve victims statewide. In March 2007, Ahimsa House launched the Emergency Animal Safehouse Services program, which houses animals via a network of foster homes and boarding facilities across the state.

TO DATE, AHIMSA HOUSE HAS PROVIDED OVER 28,000 NIGHTS OF SAFE, CONFIDENTIAL SHELTER FOR PETS IN NEED AND WE HAVE BEEN ABLE TO REUNITE 85% OF OUR CLIENTS WITH THEIR PETS ONCE EVERYONE WAS SAFE.

Ahimsa House holds an animal shelter license from the Georgia Department of Agriculture.

We are a member agency of the Georgia Coalition Against Domestic Violence and of the Gwinnett, Cobb, Dekalb, and Fulton County Family Violence Task Forces, and we are certified as a victim services provider agency by the Georgia Criminal Justice Coordinating Council.

A NOTE FROM THE EXECUTIVE DIRECTOR:

Dear readers,

It was three days before Christmas, and 13 dogs needed to come into our emergency shelter program. Ten of them were three-week-old puppies, along with their mother.

They were too young to house at a boarding facility, and our foster volunteers either had full houses or were out of town for the holidays.

They were two hours from Atlanta in a town with only two veterinarians, and their owner didn't have transportation.



It was a fitting situation to cap off a year in which crisis calls, requests for services, and the number of animals entering our program all went through the roof. But we still made it work. The mother dog and other two adult dogs are safe in one of Ahimsa House's loving foster homes, as we work toward reuniting them with their owner once she is living safely and independently. And thanks to our carefully built partnerships with pet rescue organizations, the puppies have been adopted into forever homes.


